The partnership will also see the District Supply Taro and Sweet Potato to CPL, for it's Port Moresby-based Stop & Shop Supermarkets.

Mr. Navin Raju, CEO of CPL Group, emphasized the company's commitment: "We continue to believe in Papua New Guinea's potential, and we are pleased to enter into this partnership whereby the people of Hela Province will be the biggest benefactors".
