## **Properties Supervisor**

- Ensure properties meet PNG building codes, environmental regulations, and safety standards.
- Perform regular safety inspections to identify and mitigate hazards.
- Maintain accurate records of safety inspections, property conditions, and tenant communications.
- Assist in preparing and managing budgets for maintenance and repairs; monitor expenditures to stay within budget.
- Suggest and implement cost-effective strategies for property management and service improvement.
- Negotiate service agreements with local vendors and contractors to ensure quality and value.
- Monitor contractor performance to ensure compliance with required standards.
- Approve invoices and ensure timely payments to vendors and service providers.
- Provide regular reports on property conditions, safety compliance, and tenant feedback.
- Document incidents and actions taken for clear record-keeping.
